Children, young people adults and parents understand the risks of sexual exploitation and what to do if they are worried for themselves or someone else

Practitioners confident in recognising and responding to concerns of sexual exploitation

Children, young people and adults receive a timely response to concerns

The voice of young people and adults informs the work of NSCB/NSAB

Children, young people and adults have timely access to appropriate therapeutic services

Partners supporting financial investment

STEPS WE WILL TAKE

- Strengthening of the M-SET scorecard & missing data
- Strengthen the sharing of intelligence from Missing Return Home Interviews
- Update of Northumbria Police problem profile
- Roll out PACE training programme 2018 for practitioners who work with parents
- Explore work around boys and men
- Raise awareness amongst children, young people and adults
- Raise awareness in BME communities
- Explore work around harmful sexual behavior
- Explore criminal exploitation/county lines
- Engage with out of school settings, sports clubs, theatres etc.
- Develop a young people's version of the joint SE SCR learning
- Implement the learning from the Joint SE SCR
- Produce/promote local publicity materials

HOW?

- Set up task and finish groups progress the steps
- NSCB and NSAB to periodically undertake a sample of CSE/SE Audits
- Twice yearly learning from the SE Hub to M-SET on its outcomes and effectiveness
- NSCB/M-SET to monitor progress via its performance scorecard
- Quarterly Return Home Interview report to M-SET
- Liaise closely with the NSCB/NSAB Community Engagement Group
- Twice yearly update on the progress of the joint SE Action Plan
- Quarterly reporting into NSCB/NSAB to oversee progress
- M-SET to monitor progress of the Police and Local Authority Missing Person Improvement Plans twice yearly
- Continue to engage with Newcastle Youth Council, SCARPA, Care Leavers Group
